

LCFC Matchday Live Competition – T&Cs

1. The Promoter is Leicester City Football Club Limited (reg. company number 04593477) whose registered office is at King Power Stadium, Filbert Way, Leicester, LE2 7FL.

2. Eligibility

- 2.1 The competition is only open to all residents in the UK aged 18 years or over, **except** (i) employees of the Promoter or its holding or subsidiary companies; (ii) employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the competition or its administration; or (iii) members of the immediate families or households of (i) and (ii) above.
- 2.2 In entering the competition, you confirm that you are eligible to do so and eligible to claim the prize. The Promoter may require you to provide proof that you are eligible to enter the competition.
- 2.3 The Promoter will not accept competition entries that are automatically generated by computer, completed by third parties or in bulk, illegible or incomplete.

3. The Competition

How to enter

- 3.1 No purchase necessary. Internet access required.
- 3.2 The competition will run from 16:00 on Saturday 3 April 2021 (the "**Opening Date**") to 18:45 (the "**Closing Date**") inclusive.

- 3.4 To enter the competition, you will need to send an email to competition@lcfc.co.uk with your name, address and your answer to the competition question as "year" (e.g., "2021") by the Closing Date (an "Entry").

- 3.5 All Entries must be received by the Promoter by no later than 18:45 on the Closing Date. All Entries received after the Closing Date are automatically disqualified.
- 3.6 The Promoter will **not** accept:
- (a) responsibility for Entries that are not received or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
